

## Greenways

- Independent non-motorized routes, mainly using disused railways and canal towpaths.
- Safe, accessible and very attractive
- Easy access to areas of outstanding natural beauty (e.g. mountainous areas, by way of tunnels and viaducts).

#### **European Greenways Association**

- Created in 1998 in Namur (Wallonia, Belgium) with the aim:
  - > to make an inventory of existing greenways,
  - > to promote the realization of new greenways,
  - > to encourage the use of greenways in Europe.
- ✓ 51 members from 16 countries + 4 honorary members. 3 Colleges:
  - National Public Entities
  - Regional / Local Public Entities
  - > Associations

#### **C)** Special award, Green transition in greenways:

A single award will be granted to **reward actions that contribute to green transition in the greenways ecosystem**, and contribute to achieve the Sustainable Development Goals (SDGs). Initiatives will be related to the greenway itself, or to greenway-based tourism services or products that integrate sustainability criteria, and aimed at either one or more of these trails.

## The Special award will be addressed only to greenways using disused railways, as a special form of circular economy.

This special award is part of the activities promoted by EGWA in the coimplementation of the Transition Pathway for Tourism, to recognise initiatives addressing green transition challenges in the greenways ecosystem, and to showcase how the green transition happens on the ground.

i) reuse and valorisation of heritage transport infrastructure, namely disused railways, to promote innovative and sustainable forms of tourism, for instance slow tourism (e.g. cycle tourism);





Ojos Negros / *Black Eyes* Greenway Former mining train. 167.5 Km, it is the longest in Spain.



 ii) deployment of new nonmotorised infrastructures, and the upgrade of the existing ones for cycling and walking





A dense network of bike paths of over 1,200 kilometers connecting greenways, waterways and other cycle routes, to favour the transition to active daily mobility in a safe way, in one of the largest conurbation in Europe.

- iii) connectivity improvement between the non-motorised routes (as greenways and cycle routes) and the main attractions nearby (natural as e.g. N2000, cultural and natural UNESCO sites and other heritage assets), small villages and surrounding areas;
- **Cyklostezka Sázava.** Follows the river Sázava and connects towns of Přibyslav and Sázava; along connecting cycle route 19 also UNESCO site Pilgrimage Church of St John of Nepomuk in Žďár n.S. The greenway uses 120 years old railway Havlíčkův Brod – Žďár n. S.



iv) connectivity Improvement with public transports to facilitate intermodality, removing obstacles to favour cycle routes, their services and attractions, for tourists and local people;

#### -Research on sports existing offer in Greenways.

Good practices and Innovative sport activities that are organised in greenways or that could be transferable.

Mapping of potential new greenways: all partners will identify potential greenways in their regions.

-Develop a Sports Activities Programme & Sport Training of Trainers (SToT) for Greenways, dealing with transversal topics such as environmental awareness and circular economy.

#### -Design a Strategy for Sport Activities Programs in Greenways.

Focus Groups to analyse and propose implementation possibilities to enhance local economy and revitalize abandoned areas through sport.

## Belgium: Café Welkom Veloclub on this greenway!




- > A friendly cycling club promoted by the owner of a caffe in Flanders
- Started in 2015, goal retro club. First spontaneous women's club and then mixed. Rikken & Yvonnekes: more girls than boys.
- The boys "De Rikken", the girls "De Yvonnes". Named after two famous champion cyclists in Flanders, de Rikken (Rik Van Steenbergen and Rik Van Looy) and Yvonne Reynders (also a famous female champion cyclist in the past)!
- Participants meet for cycling rides twice a week along sections of the #greenway (Kempen-Hageland route L 29) and non-motorised or low-traffic roads in the protected landscape area of #Merode.
- > Riding in a group makes them feeling more safety and socially comfortable.
- The greenway goes through Herentals– Westerlo Hulshout Herselt Aarschot (municipalities), including a protected landscape area: landscape park De Merode

INNOVATIVE EDUCATION CENTER

- A new electric bike rental system that gives services in a unified way to 15 communities, of the future Thayaland region, and two communities of the small region ASTEG.
- The THEO system promotes active mobility and healthy leisure in the territory, and contributes to reducing greenhouse gas emissions, which in turn is made possible by a nonmotorised, low-traffic infrastructure where the Tayarunde greenway forms the backbone of the network.

- Sport event carried out before the pandemic, in 2019, to celebrate the 75th anniversary of the Slovak National Uprising.
- Sport combined with cultural inputs where participants were riding their bikes on the Cyklokorytnička greenway while discovering the history of the SNU.
- Various small stations were built on the greenway where participants could stop anytime and learn about the SNU.

## Italy: La Spoleto-Norcia in MTB



- A bike race along the former Spoleto-Norcia Railway.
- The event takes place every year and has reached 8 editions.
- Spoleto-Norcia in MTB aims to promote the former Spoleto-Norcia Railway and, to raise the awareness of the public authorities in order to speed up the complete restoration work.
- Organized by the sport association @mtbclubspoleto founded in 1992, it has become the largest cycling event in Central-Southern Italy.
- The event includes a programme of talks about the importance of the nature for human well-being.
- During the event possibility of participating in the trekking activities, organised by SpoletoCammina or in the inclusive cycle tour.

We implement solutions which we have learned in OurWay project:

Regional Bicycle Policy is approved by MB of Podkarpackie Region, Bicycle Policy Officer is established, the documentation of the bicycle trails in Bieszczady Mountains is ready for building and wait for money from EU.

Kasia Madej (you met her during the project) organize bicycle trips in Beskid Niski, Bieszczady and abroad; we are in constant contact with our stakeholders we met in the project etc. – in my opinion OurWay project gave us the impuls for development this branch of tourism/quality of life/ideas for life/development of the region.




