Why is tourism so important for local and regional authorities?

- 10% GDP at EU level...
- ... but significantly more at regional level:
 - 63% in the South Aegean
 - 40% for the Balearics
 - 30% in Malta
 - nearly 15% in Tirol and in Western Pomerania
- Same goes for the jobs: 12% EU-wide

A fragile sector?

- 2019: 2.88 billion nights spent in tourism accommodation
- 2020: domestic tourism down by 33.4% and international by 70%
- 2023: 2.94 billion
- 2024 data: expected next week
- 2025: 1.3 billion nights in first 6 months the highest figure ever observed for the first 2 quarters of a year
- Six out of ten nights spent in Spain, Italy, France and Germany








How popular are our regions?



Short term rentals

Guest nights spent at short-stay accommodations booked via online platforms (NUTS2, 2024)



- ➤ 2024 854 million nights were booked via collaborative economy platforms
- 19% more than in 2023.
- on average 2.34 million guests per night

- Paris nearly 65 000 guests per night
- city tourism rebounded sharply with all major cities surpassing their prepandemic records
- the strongest year-on-year growth in 2024: Milan (+27%), Rome (+24.9%) and Madrid (+24.4%)

Getting hotter

- Europe is the fastest warming continent on Earth
- Cities like Rome or Madrid: twice as many days over 35 C
- Heat related deaths: 68 000 in summer 2024
- Coolcation here to stay

Getting drier

- Water scarcity in the Mediterranean: up to 70% of the population
- 41% of the EU population experience water stress
- A tourist consumes 300-2,000 litres per person per day, up to 8 times more than a resident

- > Over 1 million hectare burnt
 - Castilla y Leon 32 wildfires
 - Vila Real 10 days
 - Zakynthos evacuated
- ➤ UN WMO: likely increase by 50% by 2010

CoR sustainable tourism agenda (2)

Forthcoming opinion "Towards sustainable and resilient tourism in the European Union: Strategy for balanced and adaptive management"



- <u>Limit permits</u> in areas with overtourism or housing pressure, as part of data-driven adaptive management
- specific <u>funds</u> to support the transition to sustainable tourism in regions affected by seasonality, permanent and significant pressure from tourism, a high degree of specialisation, and asset degradation
- strict EU-wide <u>water-efficiency standards</u> for tourist accommodations and incentives for wastewater reuse in the sector;
- alignment with the transition to a <u>circular economy</u>, fostering responsible production and consumption, waste reduction, energy efficiency, resource reuse and ecosystem protection
- specific <u>training programmes</u> for tourism managers to improve their skills in sustainability, innovation and participatory governance
